I am happy to inform you that, you have been selected for appointment as 'Assistant Professor' (ST Category) in the Department of History, Mangattuparamba Campus, Kannur University, in the Academic Level 10 of 7th Central Pay commission in the pay matrix 57,700/- 1,82,400/-, as per the Provisional Rank list approved by the Syndicate vide reference (2) above.

The appointment will be as per the provisions of the Kannur University First Statutes,1998 and the terms & conditions laid down by the Government of Kerala/University in this regard.

The appointment will be on regular basis and the Service is liable to be terminated as and when the vacancy ceases to exist.

You will be on probation for a period of one year within a continuous period of two years with effect from the date of joining duty.

You are requested to report for duty before the undersigned within fifteen (15) days from the date of receipt of this letter along with the following certificates, in original and photo copy of the certificates shall be submitted.



- Certificates to prove age, qualifications, experience, if any
- Medical Certificate of fitness from an approved Civil Surgeon/ Equivalent authority.
- Community Certificate.

It is also informed that the appointment is offered adhering to the G. O, cited vide reference (4). As per the G.O., " in the case of officiating appointments from a higher time scale of pay to a lower time scale of pay, by direct recruitment, the Officer's officiating pay in the lower time scale shall be fixed at the minimum of the scale of pay of the new post, without considering his pay in the higher time scale, except in the cases where such appointments are made in accordance with the Special Rules applicable to such appointments". Since no special rules have been framed in Kannur University for the appointments, pay shall be fixed at the minimum of the scale of pay of the post. Hence, Protection of Pay to the incumbents belonging to higher time scale, who join in the lower time scale, will not be granted.

The G.O referred vide (5) above, with regard to National Pension System (NPS) will be applicable, wherever necessary.

The candidates who acquired PG Degree/Ph.D. Degree from Institutions outside Kerala (except regular mode) are directed to produce Equivalence/ Recognition Certificate from Kannur University and those acquired Ph.D. Degree from Institutions abroad are directed to produce Equivalence/ Recognition Certificate from AIU.

If the candidate does not join within fifteen (15) days, the appointment offered, will be cancelled.
